While many of us Napa Valley home, vineyard, winery & property owners are familiar with the increased traffic from our vineyard and winery neighbors, the proposed *Mountain Peak Winery* (100,000 gallon winery; 15,000+/- annual tourists; +/- 33,424 sf of caves; 2-100,000 gallon water tanks; marketing events... some lasting until 10PM!) at the very top of Soda Canyon **is unprecedented in size and scope for this remote and rural area.**

Mountain Peak and the carloads of tourists trekking up and down Soda Canyon Road 7 days per week, if approved, will dramatically and adversely impact the rural peace and quiet enjoyment we all love about Soda Canyon. This is why the **Protect Rural Napa Education Fund** has made opposing *Mountain Peak* one of its signature campaigns in its county-wide program to promote land conservation awareness, education and outreach in Napa County. Our advisory group of neighbors from the Soda Canyon and greater Napa communities has spent countless hours researching, analyzing, and preparing to combat all the issues and impacts that *Mountain Peak* will have on our community.

Thankfully, and as a direct result of your participation and support, we now have over 800 signatures opposing the *Mountain Peak* project! We also deeply appreciate those who attended the July 20, 2016 permit hearing, which was continued to **Jan. 4th, 2017.** We are again ramping up our opposition efforts and **sincerely hope to see you there to support this cause!**
