On March 10, 2015, the Board of Supervisors and Planning Commission held a special joint session public meeting for purposes of addressing concerns about the cumulative impacts of new development on the County and providing direction to staff on potential solutions. The Napa County Agricultural Protection Advisory Committee (APAC) is an ad hoc committee comprised of members of the wine industry, agriculture, environmental groups, neighborhood/community groups, each of the five municipalities, general business community, a farmworker and an at-large member from each Supervisorial district. The Agricultural Protection Advisory Committee (APAC) serves as an advisory committee to the Planning Commission for purposes of making recommendations to the Planning Commission on proposed revisions to the Winery Definition Ordinance (WDO). The Agricultural Protection Advisory Committee (APAC) will provide its recommendations on proposed revisions to the WDO to the Planning Commission on or before November 10, 2015.

On March 17, 2015, Resolution 2015-31 approved formation of the ad hoc Agricultural Protection Advisory Committee comprised of wine industry, agriculture, environmental groups, neighborhood/community groups, each of the five municipalities, general business community and at large members from each supervisorial district.

The committee will meet at 10:00 a.m. the 2nd and 4th Monday of every month beginning April 13, 2015.
